## CORPORATE WARRANTY DEED

In consideration of ONE HUNDRED EIGHTY THOUSAND DOLLARS (\$180,000) to the undersigned grantor, DANTRACT, INC. a corporation, (herein referred to as GRANTOR) in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents grant, bargain, sell and convey unto THE BOARD OF MISSIONS AND CHURCH EXTENSION, BIRMINGHAM-EAST DISTRICT, THE UNITED METHODIST CHURCH, a corporation (herein referred to as GRANTEE) the following described real estate, situated in Shelby County, Alabama, to-wit:

Part of the SW% of NW% of Section 32, Township 18 South, Range 1 West, being more particularly described as follows: Commence at a point where the south line of NW2 of said Section 32 intersects the West right of way line of State Highway No. 119 (where same is marked by an existing iron pin); thence northeasterly along said west right of way line for a distance of 250.00 feet to an existing iron pin; thence turn an interior angle of 86° 25' 48" and run in a northwesterly direction for a distance of 266.69 feet to the point of beginning of the property hereby conveyed; thence continue along last mentioned course for a distance of 498.42 feet to an existing iron pin; thence turn an interior angle of 99° 04' 15" and run in a southwesterly direction for a distance of 568.27 feet to an existing iron pin; thence turn an interior angle of 60° 33' 19" and run in an easterly direction for a distance of 627.25 feet; thence turn an interior angle of 110° 22' 26" and run in a northeasterly direction for a distance of 342.78 feet, to the point of beginning.
