PARTIAL RELEASE OF MORTGAGE

A part of the SW 1/4 of the NE 1/4 of Section 17, Township 19 South, Range 2 West, more particularly described as follows: Commence at the Northwest corner of the SW 1/4 of the NE 1/4 of said Section 17; thence run East along the North line of said SW 1/4 of NE 1/4 for a distance of 923.70 feet; thence turn 38 degrees 15 minutes 25 seconds right and run Southeasterly for a distance of 108.28 feet to the point of beginning and a point on the Southeasterly right of way of Sandpiper Lane; thence continue along the last described course for a distance of 140.43 feet; thence turn 92 degrees 28 minutes 25 seconds left and run Northeasterly for a distance of 189.83 feet to the North line of said SW 1/4 of NE 1/4; thence turn 125 degrees 47 minutes left and run West along the North line of said SW 1/4 of NE 1/4 for a distance of 170.64 feet to the Southeasterly right of way of Sandpiper Lane; thence turn 56 degrees 55 minutes 23 seconds left to tangent to a curve to the right, said curve having a radius of 605.06 feet, an intersection angle of 7 degrees 57 minutes 43 seconds; thence run Southwesterly along said right of way of Sandpiper Lane and arc of said curve for a distance of $8\overline{4.08}$ feet to the point of beginning; being situated in Shelby County, Mineral and mining rights excepted.
