Kelley, husband and wife, as joint tenants with the right of survivorship, all its rights, title, claim, interest, equity and estate in and to the following described lands lying in the County of Shelby, State of Alabama, to-wit:

Lot 5 in Block 2 of Columbiana Homes, Inc. Subdivision, as the same appears on the map of said subdivision which is recorded in the office of Judge of Probate of Shelby County, Alabama, in Map Book 3, Page 82. Subject to utility easements and road rights of way of record.
