ARTICLES OF INCORPORATION OF PROPERTY TAX CONSULTANTS, INC.

The undersigned, acting as the sole incorporator of a corporation under the Alabama Business Corporation Act, adopts the following Articles of Incorporation for such corporation:


FIRST: The name of the corporation is Property Tax Consultants, Inc.

- (e) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations

of, corporations, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof.
