Pursuant to the provisions of Section 10-2A-113 of the Code of Alabama, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Columbiana Bancshares, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on January 29, 1988, in the manner prescribed by the Alabama Business Corporation Act:

The sixth sentence of Article Four of the Articles of Incorporation which read as follows:


"The number of common shares authorized is 50,000 shares, and the par value of each such share is \$1.00."

is hereby amended to read as follows:

"The number of common shares authorized is 100,000 shares, and the par value of each such share is \$.10. Each presently authorized share which may be in treasury or outstanding immediately prior to such increase shall be changed into three shares having the same characteristics."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 50,043; and the number of shares entitled to vote thereon was 29,472.

FOURTH: The number of shares voted for such amendment was 27,674; and the number of shares voted against such amendment was 0.



FIFTH: The amendment changes the amount of stated capital from \$384,321.75, divided into 29,472 shares of \$1.00 par value common stock and 20,571 shares of \$17.25 par value preferred stock to \$363,691.35, divided into 88,416 shares of \$.10 par value common stock and 20,571 shares of \$17.25 par value preferred stock.


