KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, as President and Secretary of Gulf Aviation, Inc., a corporation organized and existing under the laws of the State of Alabama, hereby certify that, in accordance with Code of Alabama 1975, Sections 10-2A-110 and 10-2A-113, the Articles of Incorporation were amended by a unanimous vote of the Directors and the Shareholders, on the 7th day of March, 1988, on which date there were six hundred fifty (650) shares outstanding and entitled to vote thereon, as follows:

ARTICLE I of the Articles of Incorporation is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

"ARTICLE I

The name of the Corporation shall be Phoenix Aviation of Alabama, Inc., and any and all references to Gulf Aviation, Inc. shall hereafter be deemed to refer to Phoenix Aviation of Alabama, Inc."

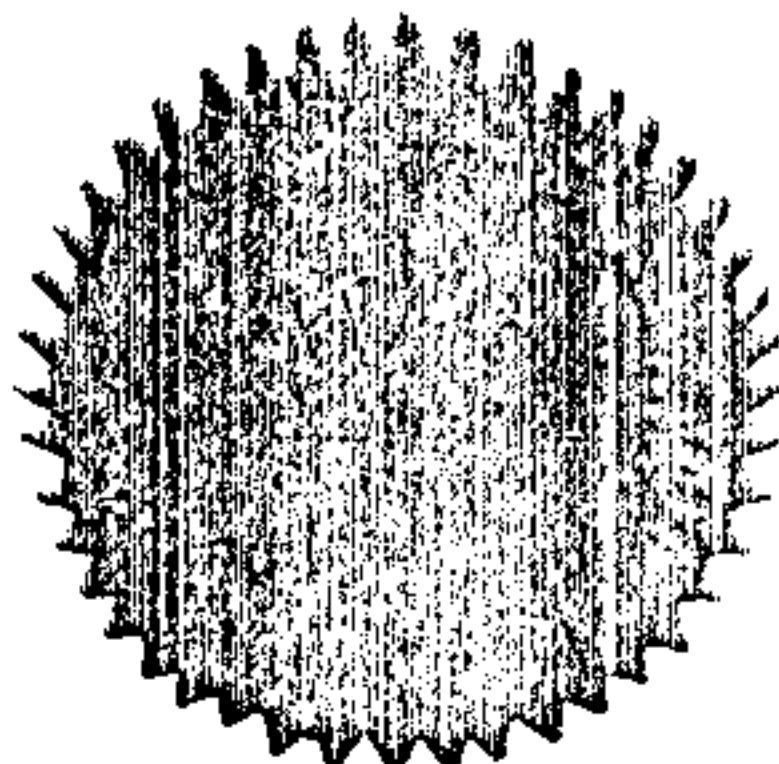
