

Last Will and Testament

OF

FRANK ROOSEVELT DANIEL

I, FRANK ROOSEVELT DANIEL, a resident of the State of Alabama, and over the age of nineteen (19) years, being of sound mind and disposing memory, do hereby make and publish this my Last Will and Testament, hereby revoking all former Wills and Codicils which may have been at any time heretofore made by me.

FIRST: I hereby direct that all of my just debts, funeral expenses, expenses of a last illness, if any, and the costs of administration of my estate be paid as soon after my death as practicable.

SECOND: All the rest, residue and remainder of my property, of every nature and description, real or personal, wherever located, whether acquired before or after execution of this Will, I give, devise and bequeath to my wife, BETTY CARROLL DANIEL, to be hers, in fee simple, absolutely and forever.

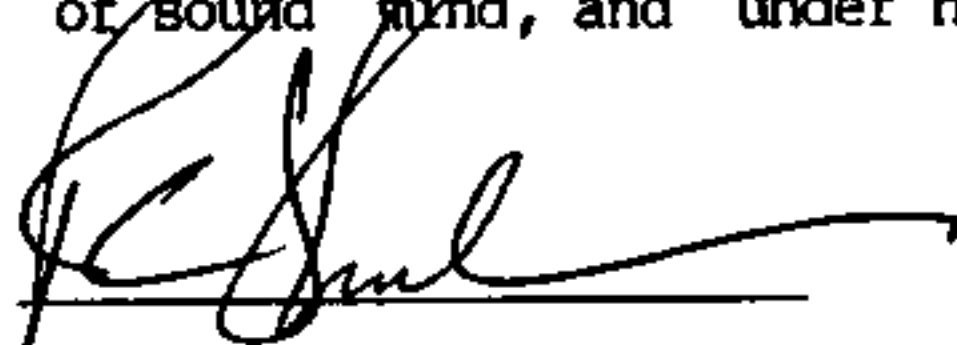
THIRD: I hereby nominate and appoint my wife, BETTY CARROLL DANIEL, as Executrix of my estate and to serve as same without being required to furnish bond or security. In the event that she predeceases me, or for any reason shall fail to qualify as Executrix hereunder, of having qualifed, shall die or resign, then, and in either of such events, I hereby direct that the Pastor of the church which I am a member of at the time of my death, or his successor, be appointed alternate Executor. Further, I direct that they shall not be required to furnish bond or security in any jurisdiction.

FOURTH: I hereby fully authorize and empower the Executrix the full power to sell, lease, mortgage, pledge, invest, reinvest, exchange, manage, control, and in any way, use and deal with any and all property of my estate, without any application to any Court, or Judge thereof, for leave or confirmation, unless the same shall be expressly required by law.

I, FRANK ROOSEVELT DANIEL, the testator, sign my name to this instrument this 8th day of April, 1988, being first duly sworn, do hereby declare to the undersigned authority that I sign and execute this instrument as my Last Will and Testament and that I sign it willingly, that I execute it as my free and voluntary act for the purposes therein expressed, and that I am nineteen (19) years of age or older, of sound mind, and under no constraint or undue influence.
