My name is Robert E. Jeffers and my residence address is Route 3, Box 1475, Pell City, Alabama 35125.

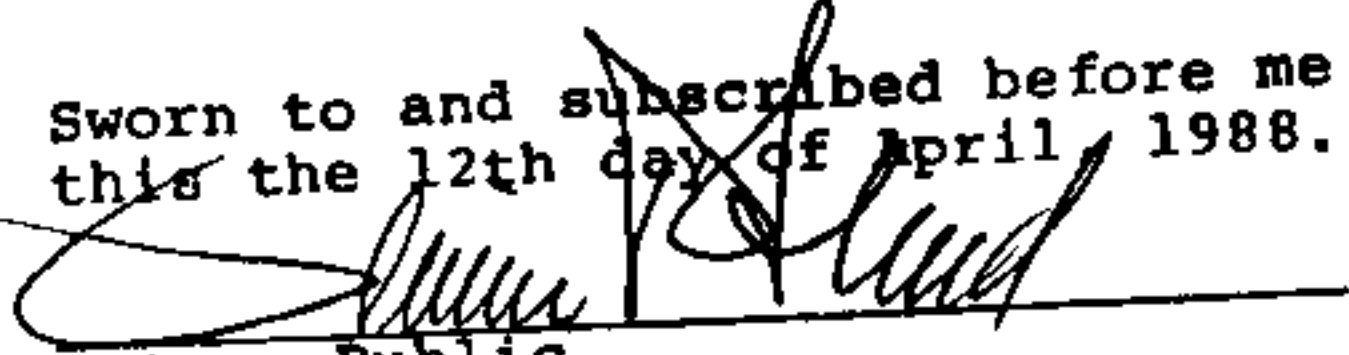

ASSIGNMENT OF NOTE AND MORTGAGE

1. Whereas Joseph Calvin Smith, Jr. and wife, Barbara Jean Smith (Assignors) is indebted to Robert E. Jeffers (Assignee) upon a promissory note dated October 17th, 1987, signed by Assignors, payable to Assignee on the 17th day of each month beginning the 17th day of November, 1987, and each month thereafter until paid in full, in the principal sum of \$25,000.00 with interest at 0% per annum. Payments are to be \$1,000.00 per month.

2. Assignors owns rights to the payment of money presently due or to become due from third parties in the aggregate sum of \$50,000.00. This debt is evidenced by a note and mortgage signed by Barbara A. Burns dated the 20th day of September, 1987.

3. For a valuable consideration, Assignors assign and transfer the note and mortgage and all amounts due to Assignors up to the amount due and payable on the note signed by Assignors to Assignee. Assignee will be entitled to said funds only in the event that the Assignors default on said note.

4. This assignment secures the promissory note described in paragraph 1.

5. Borrower covenants and warrants that:

(a) Borrower is the owner of the note and mortgage described in paragraph 2,

(b) The amount of the note and mortgage is true and accurate.

(c) Assignor will not impair the value of the note and mortgage.

Assignors have no knowledge of any claims, offsets or defenses on said note or mortgage.

6. Upon full payment of the Secured Indebtedness, this assignment shall terminate.

7. Regardless of any provision contained in this instrument or in any note evidencing the Secured Indebtedness, Assignee shall not be entitled to receive or collect any interest.

8. This agreement is binding upon Assignors, its successors and assigns, and shall inure the benefit of Assignee, its successors and assigns.

\$1,000.00 per month beginning November 17, 1987 and on the 17th day of each month thereafter until paid in full.

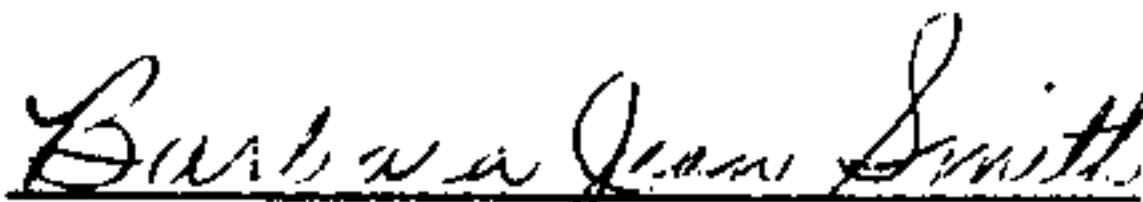

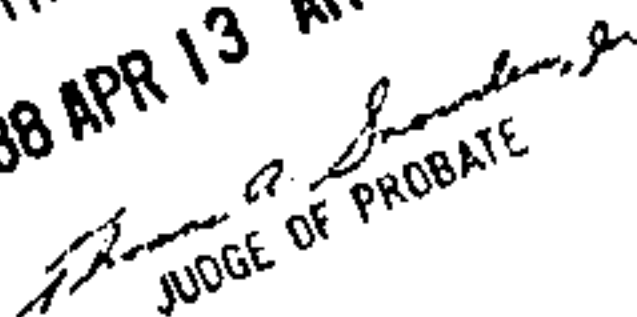
