PARTIAL RELEASE

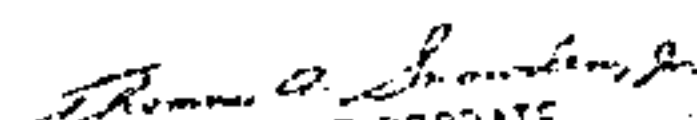
