Comes now the Plaintiff, ARTHUR JEROME HARRELL, and claims of the Defendants, CLINTON BRUCE DARDEN, A/K/A C.B. DARDEN, A/K/A BRUCE DARDEN, NANCY E. DARDEN, and all fictitious parties who are not presently known to the Plaintiff, but will be substituted by the Plaintiff when discovered, that:

- COUNT ONE -

- 1. On or about February 14, 1988, the Defendants all, and also in particular CLINTON BRUCE DARDEN and NANCY E. DARDEN, represented to the Plaintiff with the intent to trick and deceive, the following:
- A. That they were in need of monies, specifically TEN THOUSAND 0/100 DOLLARS (\$10,000.00) to complete construction of a house located in the Riverchase Subdivision of Shelby County, specifically,

Lot 701 Riverchase Country Club 7th Addition, as recorded in Map Book 8, Page 176 of the Probate Office Of Shelby County, Alabama.

- B. That the money advanced by the Plaintiff would be used for the purpose of finishing the house, and that the Plaintiff would be given an interest in the house as security, and that the Defendants had the remaining sums needed to finance the construction.
- C. That the Plaintiff would be paid Ten Per Cent (10%) interest annually on the outstanding indebtedness.
- D. That the Plaintiff would receive Five Per Cent (5%) of the profit from the sale of the house.
- E. That the sale price of the house to be sold was \$289,000.00.

2. The representations made by the Defendants were false, and the Defendants knew that they were false; or the Defendants, without knowledge of the true facts, recklessly misrepresented them, or the representations were made by mistake, but with the intention that the Plaintiff should rely on them. The Defendants misrepresented the actual cost of construction of the house, with knowledge that they intended to expend more on construction than the market in that particular neighborhood would bring upon sale. The Defendants further incurred debt secured by the house without

consulting the Plaintiff, and further failed to deliver a mortgage to secure the Plaintiff's interests.

3. The Plaintiff believed the representations and in reliance upon them gave the Defendants TEN THOUSAND 0/100 DOLLARS (\$10,000.00).

WHEREFORE, the Plaintiff demands judgment in the amount of ONE MILLION 0/100 DOLLARS (\$1,000,000.00) including punitive damages, interest and costs.

- COUNT TWO -

- 1. On or about February 14, 1988, the Defendants all, and also in particular CLINTON BRUCE DARDEN and NANCY E. DARDEN, represented to the Plaintiff with the intent to trick and deceive, the following:

- C. That the Plaintiff would receive Fifty Per Cent (50 %) of the profit from the sale of the house.
- 2. The Plaintiff advanced to the Defendants TWENTY-FIVE THOUSAND TWO HUNDRED 0/100 DOLLARS (\$25,200.00).
