KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on to-wit, the 31st day of July, 19 86, Gary W. Bailey, an unmarried person executed a certain mortgage on the property hereinafter described to EQUISOUTH FINANCIAL SERVICES, INC. as recorded in the office of the Judge of Probate of Shelby County, Alabama, in Volume 084, Page 740, assigned to Fleet Finance, Inc. in Volume 084, Page 744
