HEIRSHIP AFFIDAVIT

Come now Cora Mae Inabinett, the sole surviving daughter of Lillie Hawkins, and Robert B. Burns, a disinterested party, hereinafter referred to as "Affiants", and after first having been duly sworn, said Affiants hereby depose and say as follows:

1. The said Affiants have personal knowledge of the facts stated herein.
2. That Cora Mae Inabinett is an only child ever born as the result of a relationship between Lillie Hawkins and Herman Hawkins, she having been born as the result of such relationship on October 11, 1932.
3. Herman Hawkins married Lillie Hawkins on or about June 3, 1968 in Shelby County, Alabama, thereby legitimating the parentage of Cora Mae Inabinett.
4. On or about March 29, 1975, Lillie Hawkins and husband, Herman Hawkins received a conveyance of certain real estate located in Shelby County, Alabama, to-wit:

Lot 7 Block E according to Reynolds Addition to South Montevallo as shown by Map recorded in Map Book 3 page 41 in the Probate Office of Shelby County, Alabama;

said conveyance having been made upon a warranty deed, jointly for life with remainder to the survivor, and said deed is recorded in Book 291, Page 886, in the Office of the Probate Judge of Shelby County, Alabama.

5. Herman Hawkins died intestate in Shelby County, Alabama on or about July 12, 1986, whereupon all of his right, title and interest in the above described real estate was vested in Lillie Hawkins. Lillie Hawkins died intestate in Shelby County, Alabama on or about the 18th day of April, 1988, survived by her only child, Cora Mae Inabinett. Neither no petition for letters of administration or letters of testamentary were ever filed as regarding the estates of either of Lillie Hawkins or Herman Hawkins, with any court of competent jurisdiction.

6. Although Herman Hawkins had approximately seven (7) children of a prior children relationship or marriage, the Affiants are not aware of all of their names and addresses, notwithstanding the fact that Cora Mae Inabinett was the sole surviving heir of Lillie Hawkins. Said Cora Mae Inabinett is over the age of nineteen (19) years and currently resides at Apt. #23, Scotts Village, Montevallo, Alabama 35115.

7. The Affiants herein are not aware of any lawful issue or survivors of Lillie Hawkins, other than is designated above, and neither Affiant has personal knowledge of any other person or entity who has or claims any right, title or interest in any real or personal property, title to which is or was vested in Lillie Hawkins.
