1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. FIXED INTEREST RATE OPTION

The Note provides for the Borrower's option to convert from an adjustable interest rate to a fixed interest rate, as follows:

1. Option to Convert to Fixed Rate

I have a Conversion Option which I can exercise unless I am in default or this Section Al will not permit me to do so. The "Conversion Option" is my option to convert the interest rate I am required to pay by the Note from an adjustable rate to a fixed rate. The Conversion Option can be exercised only once during the life of the loan.

The conversion can only take place on the first day of August , 19 89 , or on the first day of any month thereafter until $\frac{July}{}$ 1, 19 $\frac{93}{}$. Each date on which I can exercise my Conversion Option is called a "Conversion Date."

If I want to exercise the Conversion Option, I must first meet certain conditions. Those conditions are that: (a) I must notify the Note Holder that I am doing so by the 5th day of the month immediately preceding the Conversion Date that I have chosen; (b) on the Conversion Date, I am not in default under the Note or the Security Agreement; (c) by the 5th day of the month immediately preceding the Conversion Date, I must pay the Note Holder a conversion fee of one percent (1.00%) of the principal balance I am expected to owe on the Conversion Date with a maximum of \$250.00; (d) I must qualify to convert based on the Note Holder's underwriting standards for conversions; and (e) by the 5th day of the month immediately preceding the Conversion Date, I must sign and give the Note Holder any documents the Note Holder requires to effect the conversion. If I am not permitted to convert under condition (d) above, the Note Holder will refund the conversion fee that I have paid.

2. Calculation of Fixed Rate

My new, fixed interest rate will be equal to the Federal Home Loan Mortgage Corporation's required net yield for 30-year, fixed rate mortgages covered by 60-day mandatory delivery commitments in effect on the first day of the month immediately preceding the Conversion Date, plus one-half of one percent (0.50%), rounded to the nearest one-eighth of one percent (0.125%). If this required net yield is not available, the Note Holder will determine my new interest rate by using a comparable figure. My new interest rate after conversion will not exceed 13.00.....%.

3. Determination of New Payment Amount

If I choose to exercise the Conversion Option, the Note Holder will determine the amount of the monthly payment that would be sufficient to repay the unpaid principal I am expected to owe on the Conversion Date in full on the maturity date at my new fixed interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment. Beginning with my first monthly payment after the Conversion Date, I will pay the new amount as my monthly payment until the maturity date.

B. Transfer of the Property or a Beneficial Interest in Borrower

If Borrower exercise the Conversion Option under the Note as stated in Section A of this Addendum To Adjustable Rate rider, the amendment to Uniform Covenant 17 of the Security Instrument contained in the Rider shall cease to be in effect, and the provisions of Uniform Covenant 17 of the Security Instrument shall instead be in effect, as follows:

Transfer of the Property or a Beneficial Interest in Borrower.

If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender if exercise is prohibited by federal law as of the date of this Security Instrument.

If the Lender exercises this option, Lender shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Borrower must pay all sums secured by this Security Instrument. If Borrower fails to pay these sums prior to the expiration of this period, Lender may invoke any remedies permitted by this Security Instrument without further notice or demand on Borrower.

BY SIGNING BELOW, Borrower accepts and agrees to the terms and covenants contained in this Addendum to Adjustable Rate Rider.
