TO HAVE AND TO HOLD the above granted property, together with all and singular the rights, privileges, tenements, appurtenances and improvements unto the said Mortgagee, and unto its successors and assigns forever. And we, the said Mortgagers do hereby covenant and represent unto the said Mortgagee, its successors and assigns, that we are lawfully seized in fee of the property above described; that we have a good and lawful right to sell and convey the same as foresaid; that we will warrant and defend the title to the same forever against the lawful claims and demands of all persons whomsoever. And it is further agreed that if all or any part of the Property or an interest therein is sold or transferred by Mortgagor without Mortgagee's prior written consent, excluding (a) the creation of a lien or encumbrance subordinate to this Mortgage, (b) the creation of a purchase money security interest for household appliances, (c) a transfer by devise, descent or by operation of law upon the death of a joint tenant or (d) the grant of any leasehold interest of three years or less not containing an option to purchase, Mortgagee may, at Mortgagee's option, declare all the sums secured by this Mortgage to be immediately due and payable. Mortgagee shall have waived such option to accelerate if, prior to the sale or transfer, Mortgagee and the person to whom the Property is to be sold or transferred reach agreement in writing that the credit of such person is satisfactory to Mortgagee and that the interest payable on the sums secured by this Mortgage shall be at such rate as Mortgagee shall request. If Mortgagee has waived the option to accelerate provided in this paragraph, and if Mortgagor's successor in interest has executed a written assumption agreement accepted in writing by Mortgagee, Mortgagee shall release Mortgagor from all obligations under this Mortgage and the Note.
