Part of the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 36, Township 18 South, Range  
1 East, Shelby County, Alabama, more particularly described as  
follows: Commence at the Northwest corner of the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$   
of said Section 36 and run East along the North line of said  $\frac{1}{4}$ - $\frac{1}{4}$ ,  
582.77 feet to point of beginning; thence continue along said  
North line 552.22 feet; thence angle right 88 deg. 23 min. 01 sec.  
and run Southeasterly 616.16 feet to the corner of an existing  
chain link fence; thence angle left 5 deg. 06 min. 44 sec. and  
run Southeasterly along said fence 167.28 feet to the corner of  
said fence, said corner being the Northerly side of Merry Hill  
Farm Road; thence angle right 50 deg. 36 min. 13 sec. and run
