The purpose of the Architectural Control Committee is to insure that new construction is restricted to the point that property values will be maintained.

The individuals named above have been on the committee since its inception. It is the feeling of the undersigned that some of the houses which have been constructed and were approved by this committee are below the standards required by the protective covenants.

As is stated in paragraph "q", " at any time, the then record owners of a majority of the lots shall have the power through a duly recorded written instrument, to change the membership of the committee or to withdraw from the committee or restore to it any of its powers and duties."

The duties of this committee shall remain the same as stated in paragraph "p", which is to assure that "no building shall be erected, placed or altered on any lot until the construction plans and specifications and a plan showing the location of the structure have been approved by the Architectural Control Committee as to quality of workmanship and materials, harmony of external design with existing structures, and as to location with respect to topograph and finish grade elevation. No fence or wall shall be erected, placed or altered on any lot nearer to any street than the minimum building setback line unless similarly approved."

These restrictions shall apply to any property that is in the Royal Oaks Sub-division including all existing sectors, any new sectors or any development that gains access from any street in the Royal Oaks Sub-division or uses the name Royal Oaks, or that is adjacent to property in the sub-division. The newly appointed committee will be taking over the duties effective August 17,1988.
