I, the undersigned, hereby certify that Alabama Power Company does not claim the right to construct additional lines for the transmission of electricity over or across the lands described herein below, under the authority granted in the following right of way permits:

(1) That certain instrument from Ferman Albright and wife, Mrs. Lydia J. Albright, dated June 3, 1947 and recorded in Deed Book 130, at page 77 in the Probate Court records in and for Shelby County, Alabama.

(2) That certain instrument from J. Frank Baker and wife, Sadie B. Baker dated November 11, 1948 and recorded in Deed Book 136, at page 340 in the Probate Court records in and for Shelby County, Alabama.

(3) That certain instrument from J. T. Albright, et al dated June 27, 1950 and recorded in Deed Book 142, at page 421 in the Probate Court records in and for Shelby County, Alabama.

(4) That certain instrument from J. Frank Baker and wife, Janie R. Baker dated February 1, 1969 and recorded in Deed Book 247, at page 443 in the Probate Court records in and for Shelby County, Alabama.

The purpose for which such right of way permits were acquired was for distribution lines on property other than that described below or constructed on the property but subsequently removed.

Begin at the northwest corner of the northwest quarter of the southeast quarter of Section 36, Township 21 South, Range 3 West; thence run east along the north line of said quarter-quarter section for 364.21 feet;; thence 89 degrees 8 minutes 10 seconds right, and run southerly along a fence for 522.24 feet to a fence corner; thence 86 degrees 47 minutes 50 seconds right, and run westerly for 343.51 feet to the west line of said quarter-quarter; thence 90 degrees 59 minutes right, and run 547.33 feet to the point of beginning.
