KNOW ALL MEN BY THESE PRESENTS, That I, VALERIA ESTELLE SEALE TAYLOR, of Dallas County, Alabama, do make and declare this to be my Last Will and Testament, hereby revoking any and all other Wills and Codicils heretofore made by me.

ITEM ONE: I direct that all my just debts, including the expenses of my last illness and funeral expenses and the costs of the administration of my estate, shall be paid out of my estate by my Executrix, hereinafter named, as soon as may be practicable.

ITEM TWO: I direct my Executrix hereinafter named that I be buried next to my second husband Andrew Taylor and between his grave and the grave of my aunt Ruby.




may deem advisable and in the best interest of my estate, any real or personal property owned by my estate.


