FIXED RATE LINE OF CREDIT MORTGAGE

This indenture is made and entered into this <u>31st</u> day of August , 1988, by and between Pelham Christian Fellowship, Inc., a non-profit corporation (hereinafter called the "Mortgagor"), and Karen Stephenson dba GJHG, a sole proprietorship (hereinafter called the "Mortgagee").

RECITALS

A. THE SECURED LINE OF CREDIT. Mortgagor is now or may become in the future justly indebted to the Mortgagee in the maximum principal amount of Five hundred thousand and OO/100 Dollars (\$500,000.00) (hereinafter the "Credit Limit") pursuant to a certain open-end line of credit established by the Mortgagee for the Mortgagor under an agreement entitled "Line of Credit Agreement," executed by the Mortgagor in favor of the Mortgagee, dated August 31 (hereinafter the "Credit Agreement"). The Credit Agreement provides for an open-end line of credit pursuant to which the Mortgagor (hereinafter either referred to as "Mortgagor" or "Borrower") may borrow and repay, and reborrow and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

B. INTEREST RATE. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at the fixed annual percentage rate of 9.0%.

C. MATURITY DATE. If not sooner terminated as set forth herein, the Credit Agreement will terminate ten years from the date of the Credit Agreement, and all sums payable thereunder (including without limitation principal, interest, expenses and charges) shall become due and payable in

D. MORTGAGE TAX. This Mortgage secures open-end indebtedness with an interest in commercial real property. Therefore, under the Code of Alabama 1975, as amended, the mortgage filing privilege tax shall not exceed \$.15 for each \$100.00, or fraction thereof, of the Credit Limit of \$500,000.00, which is the maximum principal indebtedness, to be secured by this mortgage at any one time.

AGREEMENT

To have and to hold the Real Estate unto the Mortgagee, its successors and assigns forever. The Mortgagor covenants with the Mortgagee that the Mortgagor is lawfully seized in fee simple of the Real Estate and has a good right to sell and convey the Real Estate as aforesaid; that the Real Estate is free of all encumbrances, except the lien of current ad valorem taxes, the prior mortgage, if any, hereinafter described and any other encumbrances expressly set forth above; and the Mortgagor will warrant and forever defend the title to the Real Estate unto the Mortgagee, against the lawful claims of all persons, except as otherwise herein

For the purpose of further securing the payment of the Debt, the Mortgagor agrees to: (1) pay all taxes, assessments, and other liens taking priority over this mortgage (hereinafter jointly called "Liens"), and if default is made in the payment of the Liens, or any part thereof, the Mortgagee, at its option, may pay the same; (2) keep the Real Estate continuously insured, in such manner and with such companies as may be satisfactory to the Mortgagee, against loss by fire, vandalism, malicious mischief and other perils usually covered by a fire insurance policy with standard extended coverage endorsement, with loss, if any, payable to the Mortgagee, as its interest may appear; such insurance to be in an amount at least equal to the full insurable value of the improvements located on the Real Estate unless the Mortgagee agrees in writing that such insurance may be in a lesser amount. Subject to the rights of the holder of the prior

mortgage, if any, set forth above, the original insurance policy and all replacements therefor, shall be delivered to and held by the Mortgagee until the Debt is paid in full and the Credit Agreement is terminated. The insurance policy must provide that it may not be cancelled without the insurer giving at least fifteen days' prior written notice of such cancellation to the Mortgagee. The Mortgagor agrees to take good care of the Real Estate and all improvements located thereon and not to commit or permit any waste thereon, and at all times to maintain such improvements in as good condition as they now are, reasonable wear and tear excepted.

The Mortgagor agrees that no delay or failure of the Mortgagee to Oexercise any option to declare the Debt due and payable shall be deemed a Owaiver of the Mortgagee's right to exercise such option, either as to any spast or present default, and it is agreed that no terms or conditions contained in this mortgage may be waived, altered or changed except by a written instrument signed by the Mortgagor and signed on behalf of the Mortgagee by one of its officers.

Upon the occurrence of an event of default hereunder, the Mortgagee, upon bill filed or other proper legal proceeding being commenced of the foreclosure of this mortgage, shall be entitled to the appointment by any competent court, without notice to any party, of a receiver for the rents, issues and profits of the Real Estate, with power to lease and control the Real Estate and with such other powers as may be deemed necessary.
