JUDGMENT AMENDING FINAL ORDER

The Court in this cause having rendered final judgment on April 10, 1987, and thereafter, the plaintiff having filed on May 8, 1987, a motion to alter or amend said judgment, or, in the alternative, to set aside said judgment and to grant to plaintiffs a new trial; and this Court having proceeded on June 9, 1987, to hear arguments in support of said motion; this Court is of the opinion that the judgment rendered was, to the extent the same is modified herein, contrary to the evidence in this cause and specifically contrary to the stipulations made by the parties plaintiff and parties defendant during the course of the trial in this cause.

IT IS THEREFORE ORDERED, ADJUDGED and DECREED by this Court that the judgment of this Court rendered on April 10, 1987 is hereby amended to read as follows:

1. That the plaintiffs are the owners of the hereinafter described property and title thereto is hereby vested and quieted in plaintiffs, to-wit:

From the S.W. corner of NE 1/4 of NW 1/4, Section 17, Township 19 South, Range 1 West, run East along the South boundary of said 1/4-1/4 a distance of 1190.78 ft.; thence, left 90 deg. 00 min. a distance of 144.68 ft. to the point of beginning; thence, continue in a straight line a distance of 100.00 ft.; thence right 90 deg. 00 min. a distance of 155.00 ft.; thence right 90 deg. 00 min. a distance of 100.00 ft.; thence, right 90 deg. 00 min. a distance of 155.00 ft. to the point of beginning. Situated in Shelby County, Alabama.

2. Also, the plaintiffs are the owners of the following described property and title thereto is hereby vested and quieted in plaintiffs, to-wit:

From the S.W. corner of NE 1/4 of NW 1/4, Section 17, Township 19 South, Range 1 West, run East along the South boundary of said 1/4-1/4 a distance of 1190.78 ft. to the point of beginning; thence, left 90 deg. 00 min. a distance of 144.68 ft., thence,

LESS AND EXCEPT THE FOLLOWING: A part of the NW 1/4 of NE 1/4, Section 17, Township 19 South, Range 1 West more particularly described as follows: Begin at the Southwest corner of NW 1/4 of NE 1/4 of said Section 17 and run North 2 deg. 50 min. West 120 feet; thence North 87 deg. 10 min. East 210 feet; thence North 2 deg. 50 min. West 210 feet; thence North 87 deg. 10 min. East 30 feet; thence South 2 deg. 50 min. East 160 feet; thence North 87 deg. 10 min. East 49.4 feet; thence South 2 deg. 50 min. East 170.0 feet to South line of said NW 1/4 of NE 1/4; thence along South line South 87 deg. 10 min. West 289.4 feet to the point of beginning. Situated in Shelby County, Alabama.

3. With reference to all the other property claimed by the plaintiffs, plaintiffs are denied the relief prayed for in the complaint.

4. That all other aspects of this Court's order of April 10, 1987 which are not specifically modified hereby shall remain in full force and effect.

5. That a copy of this order be filed in the Probate Office of Shelby County, Alabama.

6. That the costs of court accrued herein are hereby taxed against the plaintiffs.
