ORDER

THIS CAUSE coming on to be heard on April 21, 1988 on Plaintiff's Motion for Summary Judgment, which is considered by the Court to be a Motion for Partial Summary Judgment, as to Defendant, Nelson H. Head, Beverly P. Head, Jr. and James R. Foreman, and the Court, hearing the arguments of counsel for the Plaintiff and Defendants, finds that there is no genuine issue as to any material fact and that the following question of law is dispositive of all issues between the parties: Whether or not the Plaintiff is entitled to proceed to judgment and execution against the individual general partners, for the partnership debt before the partnership assets have been exhausted; the Court is of the opinion that the Plaintiff is entitled to partial summary judgment, and it is therefore ORDERED, ADJUDGED and DECREED by the Court as follows:

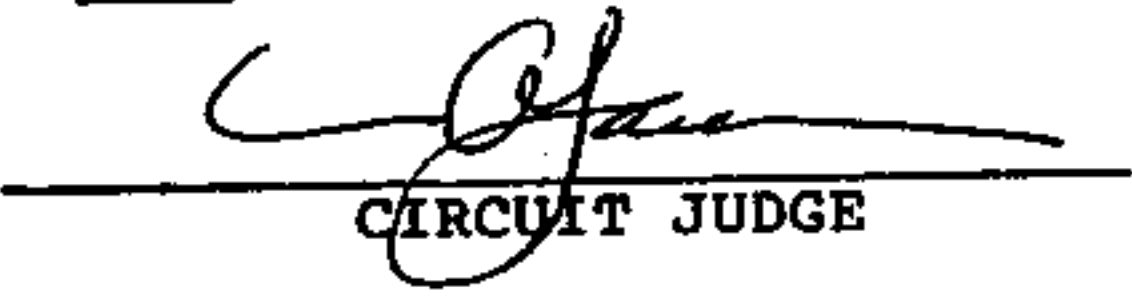

That a money judgment is hereby ordered in favor of the Plaintiff and against the Defendants, Nelson H. Head, Beverly P. Head, Jr. and James R. Foreman, in the principal sum of \$9,633.25, plus interest at the legal rate of 6% from November 25, 1986 in the amount of \$865.84, for a total of \$10,499.09. There being no just reason for delay, the Court further directs entry of a final judgment pursuant to 54(b) of the Alabama Rules of Civil Procedure.

Costs are hereby taxed against the Defendants, Nelson H. Head, Beverly P. Head, Jr. and James R. Foreman, for which let execution issue.
