POWER OF ATTORNEY

Ken Lokey Homes, Inc. hereby authorizes any of such Attorneys-in-Fact, on behalf of said Corporation to sign, execute, enter into and deliver contracts, agreements, deeds or other necessary documents, instruments or papers for the sale by Ken Lokey Homes, Inc. of finished homes or homes to be finished (together in each instance with the finished lots for the home); provided, however, that except for the sale of any lot together with such home, no such employee shall have any power or authority to sell any land whatsoever.
