    - To Lindsey Allison, the Guardian ad Litem in this cause (D) for her services rendered herein, the sum of \$350.00;
    - To Robert Dow, the real estate appraiser who was (E) employed in this cause to appraise said real property, the sum of \$325.00;
    - The remaining sum of \$25,995.62, will be held by said Melinda S. Woods, as Administratrix of the Estate of Mabel Peters, deceased, for distribution to the joint owners thereof, who are the plaintiff and the defendants herein, through the administration of said estate of Mabel Peters, deceased, as distributees of said estate, and in accordance with the law and orders of this Court.
