The AmSouth Prime Rate is one of the base rates AmSouth Bank N.A. establishes from time to time for tending purposes and it is not necessarily the best or lowest rate offered by AmSouth Bank N.A. The annual percentage rate may increase if the AmSouth Prime Rate decreases. Any increase in the annual percentage rate may result in increased finance charges and increased minimum payment amounts under the Credit Agreement. Any decrease in the annual percentage rate may result in lower finance charges and lower minimum monthly payments.
