An easement for ingress, egress and utilities; 30 feet wide, 15 feet on each side of the following described centerline:

Commence at the Northwest corner of Section 24, Township 21 South, Range 1 East, Shelby County, Alabama;

Thence run south along the west section line 622.00 feet,  
Thence turn left 91 deg. 37 min. 00 sec. and run east 341.76 feet,  
Thence turn right 95 deg. 16 min. 00 sec. and run south 15.06 feet to the center of an existing chert road and the point of beginning of said centerline,

Thence turn left 103 deg. 50 min. 41 sec. and run northeast along said chert road 294.31 feet to the point of a counter-clockwise curve having a delta angle of 74 deg. 39 min. 14 sec. and a radius of 144.25 feet,  
Thence run along the arc of said curve 187.95 feet to the point of tangent,

Thence run tangent to said curve along said chert road 647.68 feet to the center of old Lokey Ferry Road and the end of said centerline.
