### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Alabama Business Corporations Act hereby adopts the following Articles of Incorporation:

- 1. The name of the Corporation is WOLF, Inc.
- 2. The term of existence of the Corporation shall be perpetual.
- 3. The purpose for which the Corporation is organized shall be the preparation of custom millwork items for profit, as well as the transaction of any or all lawful businesses for which a Corporation may be incorporated under the Alabama Business Corporation Act.


