I

I, Clyde O. Harris, a resident of Bessemer, Jefferson County, Alabama, being of sound mind and disposing memory, do hereby make, publish and declare this to be my last will and testament, hereby revoking any and all other wills and codicils heretofore made by me.

II

I hereby direct that my hereinafter named Co-Executrixes or the surviving Co-Executrix pay all of my just debts and funeral expenses including the cost of my last illness, the cost of a suitable monument at my grave, and the cost of administration of my estate as soon after my death as shall be by them or him found convenient. I further authorize and empower my Co-Executrixes or the surviving Co-Executrix to pay any just debts or charges against my estate without the necessity or requirement that claims be first filed in the Probate Court.

III

I hereby give, devise and bequeath unto my wife, Hazel Harris, if she survives me, all of my property, both real, personal and mixed of which I die seized and possessed and to which I am entitled at the time of my death, absolutely.

If my said wife, Hazel Harris, shall predecease me, or if my said wife and I die in a common accident or common disaster or under such circumstances as to render it difficult or impossible to determine with sufficient certainty whether or not my said wife survived me, then in either such event I give, devise and bequeath unto my daughter, Clydette Harris Hughes, if she survives me, all of my property, both real, personal and mixed of which I die seized and possessed and to which I am entitled at the time of my death, absolutely.

V

I hereby nominate, constitute and appoint my said wife, Hazel Harris and my daughter, Clydette Harris Hughes as Co-Executrixes of this my last will and testament and I hereby direct that the said Co-Executrixes shall not be required to make any bond, inventory or report to any Court to qualify and act as said Co-Executrixes.

VI

I hereby authorize and empower my personal representative or representatives, as hereinabove provided, to sell at either private or public sale, without liability on the purchaser to see to the proper application of the proceeds of such sale or sales. To convey, lease or exchange all or any part of my estate, whether real, personal or mixed property; for such consideration and upon such terms and conditions as my personal representative or representatives deem proper and to the best interest of the beneficiary or beneficiaries hereinabove named; and to execute and deliver all instruments necessary or proper to evidence such sale, lease or exchange, and to collect all rents, profits, incomes, dividends, or issues due to my estate; to insure, repair or rebuild any buildings or other structures constituting a part of my estate,

and in general to do any and all things with respect to my estate that I myself might do, if living, and which my said personal representative or representatives may deem proper; and to do all of the things specified without first obtaining any order of court therefore.
