DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, Minnie Celestia Fiquette Wade, desiring to constitute a Durable Power of Attorney, and being of Chilton County, Alabama, I do hereby make, constitute and appoint my son, Charles W. Wade, III, and daughter, Minnie Wade Coggins, as my true and lawful attorneys-in-fact, for me and in my name place and stead and on my behalf and for my use and benefit to do, perform and execute all and every act that I may legally do through an attorney-in-fact and every proper power necessary to carry out the purposes for which this power is granted with full power of substitution and revocation hereby ratifying and affirming that which Charles W. Wade, III and Minnie Wade Coggins should lawfully do or cause to be done by themselves by virtue of the power herein conferred upon them.

The rights, powers and authority of my said attorneys-in-fact herein granted shall be in full force and effect upon the disability, incompetency or incapacity of the said principal Minnie Celestia Fiquette Wade, such rights, powers and authority shall remain in full force and effect thereafter until the death of the principal, Minnie Celestia Fiquette Wade, or until her disability, incompetency or incapacity is otherwise terminated. Any action taken in good faith pursuant to the foregoing authority without actual knowledge of my death shall be binding upon me, my heirs, assigns, and personal representatives.
