ASSIGNMENT OF MORTGAGE AND SECURITY AGREEMENT

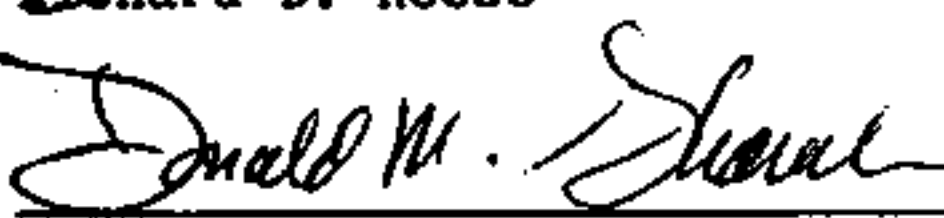
