ARTICLE ONE

NAME

The name of the corporation is Faith Temple Deliverance Center, Inc.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual; and the corporate existence will commence on the filing of these articles with the Judge of Probate.

ARTICLE THREE

PURPOSE



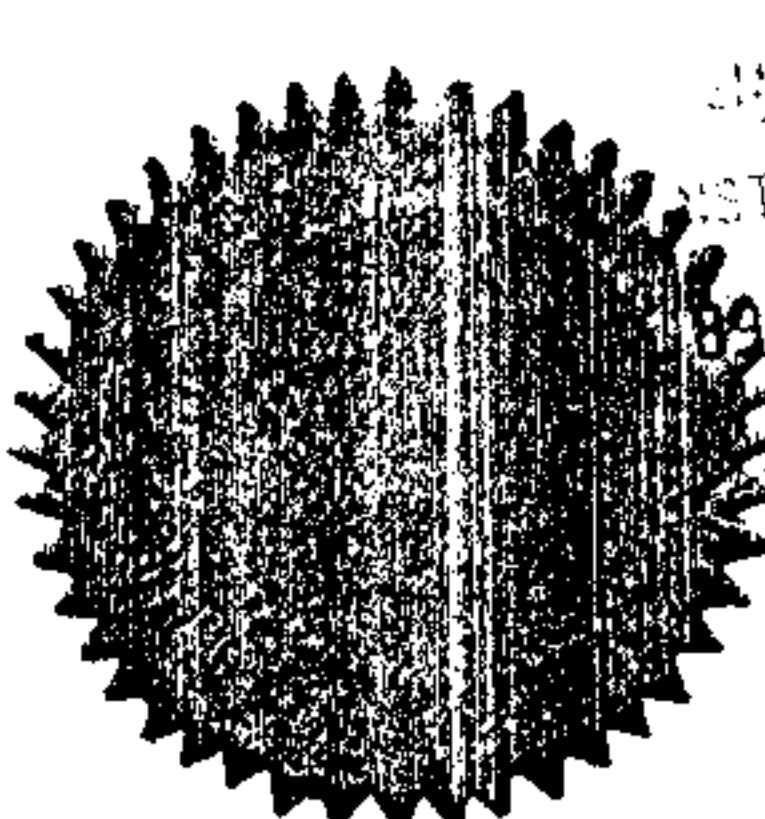
