Any claim, demand or charge that is made against property because an obligation has not been fulfilled is known as a "lien." I will promptly pay payments. or satisfy all liens against the Property that may be superior to this Mortgage. However, this Mortgage does not require me to satisfy a superior lien if: (a) I agree, in writing, to pay the obligation which gave rise to the superior lien and Lender approves the way in which I agree to pay that obligation; or (b) I, in good faith, argue or defend against the superior lien in a lawsuit so that, during the lawsuit, the superior lien may not be enforced and no part of the Property must be given up.

If the Property includes a unit in a Condominium Project, I will promptly pay when they are due all assessments imposed by the owners associa-Condominium Assessments tion or other organization that governs the Condominium Project.
