ARTICLES OF INCORPORATION

FIRST: The name of the corporation is SIGLE CONST. CO., INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To purchase, sale, develop, mortgage, convey and to do each and every other thing necessary for the successful construction and sale of residential and commercial property, and each and every other activity allowed a corporation by the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000), at no par value per share. There is only one class of stock.

directors until the first annual meeting of shareholders or until their successor is elected and shall qualify is:




