Reynolds, a married woman (hereinalter referred to as "Mortgagor", whether one or more), and Coosa Pines Federal Credit Union, Coosa Pines, Alabama 35044, (hereinalter referred to as "Mortgagee").

WITNESSETH:

--- WHEREAS, The said Morigagor is justly indebted to Morigages in the sum of <u>Thirty Thousand and no/100----</u> Rate Mortgage Note (Promissory Note) of even date herewith which bears interest as provided therein which is payable in accordance with its terms.

CONNOW, THEREFORE, in consideration of the premises, and to secure the payment of the debt evidenced by said Promissory Note and any and all extensions and renewals thereof, or of any part thereof, and any additional interest that may become due on any such extensions and renewals, or any part linereof (the aggregate amount of such debt, including any extensions and renewals and interest due thereon, is hereinalter collectively called "Debt") and compliance with all the stipulations herein contained, the Mortgagor does hereby grant, bargain, sell and convey unto the Mortgagee, the following . County, Alabama (said real estate being hereinafter called "Real Estate"), to-wit: Shelby described real estate, situated in _____

A plot of land more particularly described as follows: at the NW corner of SE of SE of Section 17, Township 19, Range 2 East and run thence South along the West boundary of said 1-1 Section 420 feet to the SW corner of the Clovinski Reynolds lot; and which is the point of beginning of the land herein described and conveyed; thence Easterly along the South boundary of said Clovinski Reynolds lot 420 feet; thence turn a 90 deg. angle to the right and run Southerly 420 feet; thence turn an angle of 90 deg. right and run Westerly 420 feet to the West boundary of said 1-1 Section; thence North along West boundary of said 1-1 Section 420 feet to point of beginning; being situated in Shelby County, Alabama.

ALSO, an easement for ingress and egress 20 feet wide over Mortgagor's remaining lands to Shelby County Highway No. 83.

The property described above is not the homestead of Betty S. Reynolds.

Together with all the rights, privileges, tenements, appurtenences, fixtures and improvements appertaining to the Real Estate, all of which shall be deemed Real Estate and shall be conveyed by this mortgage.

TO HAVE AND TO HOLD the Real Estate unto the Mortgages, its successors and assigns forever. The Mortgagor covenants with the Mortgages that the Mortgagor is lawfully seized in fee simple of the Real Estate and has a good right to sell and convey the Real Estate as aforesaid; that the Real Estate is tree of all encumbrances, except as described herein, and the Mortgagor will warrant and forever defend the title to the Real Estate unto the Mortgages, against the lawful claims of all persons, except as otherwise herein provided.

For the purpose of further securing the payment of the debt, the Mortgagor agrees to: (1) pay promptly when due all taxes, assessments, and other liens taking priority over this mortgage (hereinalter jointly called "Liens"), when imposed legally upon the Real Estate and it default is made in the payment of the Liens, or any part thereof, the Morigagee, at its option, may pay the same; (2) keep the Real Estate continuously insured, in such manner and in such companies as may be satisfactory to the Mortgages, against loss by fire, vandalism, malicious mischief and other perils usually covered by a fire insurance policy with standard extended coverage endorsements, with lose, if any, payable to the Mortgagee, as its interest may appear; such insurance until the debt is paid in full. The original insurance policy, and all replacements therefor, shall be delivered to and held by the Morigages giving at least ten days prior written notice of such cancellation to the Morigages. The Morigages herby assigns and all replacements therefor must provide that they may not be cancelled without the insurer security for the payment of the debt, each and every policy of hazard insurance now or hereafter in effect which insures said improvements, or any part thereof, together with all the right, title and interest of the Mortgagor in and to each and every such policy, including but not limited to all of the Mortgagor's right, title and interest in and to any premiums paid on such hazard insurance, including all rights to return premiume. If the Mortgagor fails to keep the Real Estate insured as specified above then, at the election of the Morigages and without notice to any person, the Morigages may declare the entire debt Mortgages declares the entire debt due and payable, the mortgages may but shall not be obligated to, insure the Real Estate for its full insurable value (or for such lesser amount as the Mortgages may wish) against such risks of loss, for its own benefit the processor and the Real Estate for its full insurable value. same), if collected, to be credited against the debt, or, at the election of the Mortgagee, such proceeds may be used in repairing or reconstructing the improvements located on the Real Estate. All amounts sperit by the Mortgagee for insurance or for the payment of Liens shall become a debt due by the Mortgagor to the Mortgages and at once payable without demand upon or notices to the Mortgagor, and shall be secured by the lien of this mortgage, and shall bear interest from the date of payment by the Mortgages until paid at the then curennt mortgage rate at said Credit Union. The Mortgagor agrees to pay promptly when due the principal and interest of the debt and keep and perform every other covenant and agreement of the Promissory Note secured hereby.

As further security for the payment of the debt, the Mortgagor hereby assigns and pledges to the Mortgages, the following described property rights, claims, rents, profits, issues and revenues:

The Mortgagee is hereby authorized on behalf of and in the name of the Mortgagor to execute and deliver valid acquittances for, appeal from, any such judgments or awaids. The Mortgages may apply all such sums received, or any part thereof, after the payment of all the Morigages's expenses incurred in connection with any proceeding or transaction described in this subparagraph 2, including court costs and attorney's less, on the debt is such manner as the Morigages sleets, pt, at the Morigages's option, the entire amount or any part thereof so received may be released or may be used to rebuild, repair or restore any or all of the improvements located on the Real Estate.

Mortgagor agrees that, in the event that any provision or clause of the Adjustable Rate Mortgage or the Adjustable Rate Mortgage Note conflict with applicable law, such conflict shall not affect any other provisions of this Adjustable Rete Mortgage or the Adjustable Rate Mortgage Note which can be given effect. It is agreed that the provisions of the Adjustable Rate Mortgage and the Adjustable Rate Mortgage Note are severable and that, if any one or more of the provisions contained in this Adjustable Rate Mortgage or in the Adjustable Rate Mortgage Note shall for any reason be held to be invalid, lifegal, or unenforceable in any respect, such invalidity, lilegality, or unenforceability shall not effect any other provision hereof; this Morigage shall be construed egal or unenforceable provision has never bedi mad herein.

The Mortgagor agrees to take good care of the Real Estate and all Improvements located thereon and not to commit or permit any waste thereon, and at all times to maintain such improvements in as good condition as they are, reasonable wear and tear excepted.

If all or any part of the Beel Estate or any interest therein is sold or transferred by Mortgagor excluding (a) the creation of a fien or encumbrance subordinate to this Mortgage (b) the creation of a purchase money security interest for household appliances (c) the transfer by device, descent or by operation of law upon the death of a joint tenant or (d) the grant of any lessehold interest of three years or less not containing an option to purchase, Mortgages may, at Mortgages's option, declare all of the sums secured by this Mortgage to be immediately due and payable.

The Mortgagor agrees that no delay or failure of the Mortgages to exercise any option to declare the debt due and payable shall be deemed a waiver of the Mortgages's right to exercise such option, either as to any past or present default, and it is agreed that no terms or conditions contained in this mortgage may be waived, altered or changed except by a written instrument signed by the Mortgagor and signed on behalf of the Mortgages by one of its duly authorized representatives.

After default on the part of the Mortgagor, the Mortgagee, upon bil filed or other proper legal proceedings being commenced for the foreclosure of this mortgage, shall be entitled to the appointment by any competent court, without notice to any part, of a receiver for the rents, issues and profits of the Real Estate, with power to lease and control the Real Estate, and with such other powers as may be deemed necessary.

UPON CONDITION, HOWEVER, that if the Mortgagor pays the debt (which debt includes the Indebtedness evidenced by the Promiseory Note hereinshove referred to and any or all extensions and renewals thereof and any interest due on such extensions and renewals) and all other indebtedness secured hereby and reimburses the Mortgagee for any amounts the Mortgagee has paid in payment of Liene or insurance premiums, and interest thereon, and fulfills all of Mortgagor's obligations under this mortgage, this conveyance shall be null and void. But it: (1) any warranty or representation made in this mortgage is breached or proves talse in any material respect; (2) default is made in the due performance of any covenant or agreement of the Mortgagor under this mortgage; (3) default is made in the payment to the Mortgagee of any sum paid by the Mortgagee under the authority of any provision of this mortgage; (4) the debt, or any part thereof, remains unpaid at maturity; (5) the interest of the Mortgages in the Real Estate becomes endangered by reason of the enforcement of any prior lien or endumbrance; (6) any statement of lien is filed against the Real Estate, or any part thereof, under the statutes of Alabama relating to the fiens of mechanics and materialmen (without regard to the existence or nonexistence of the debt or the lien on which such statement is based); (7) any lew le passed imposing or authorizing the imposition of any specific tax upon this mortgage or the debt or permitting or authorizing the deduction of any such tax from the principal or interest of the debt, or by viture of which any tax lien or assessment upon the Real Estate shall be chargeable against the owner of this mortgage; (8) any of the stipulations contained in this mortgage is declared invalid or inoperative by any court of competent jurisdiction; (9) Mortgagor or any of them (a) shell apply for or consent to the appointment of receiver, trustee or liquidator thereof or of the Real Estate or of all or a substantial part of such Mortgagor's assets, (b) be adjudicated a bankrupt or insolvent or file a voluntary petition in bankruptcy, (c) fail, or admit in writing such Mortgagor's inability, generally to pay such Mortgagor's debts as they come due, (d) make a general assignment for the benefit of creditors, (e) sie a petition or an answer seeking reorganization or an arrangement with creditors or taking advantage of any insolvency law, (f) file an answer admitting the material allegations of, or consent to, or default in answering a petition filed against such Mortgagor in any bankruptcy, reorganization or insolvency proceedings; or (10) an order for relief or other judgment or decree shall be entered by any court of competent jurisdiction, approving a polition seeking liquidation or reorganization of the Mortgagor, or any of them, if more than one, or appointing a receiver, trustee or liquidator of any Mortgagor or of the Real Estate or of all or a substantial part of the assets of any Mortgagor; then, upon the happening of any one or more of said events, at the option of the Mortgages, the upaid balance of the debt shall at once become due and payable and this mortgage shall be subject to foreclosure and may be foreclosed as now provided by law in case of past-due mortgages; and the Mortgages shall be authorized to take possession of the Real Estate and, after giving at least twenty-one day's notice of the time, place and terms of sale by publication once a week for three consecutive weeks in some newspaper published in the county on which the Real Estate is located, to sell the Real Estate in front of the courthouse door of said county, at public outcry, to the highest bidder for cash, and to apply the proceeds of said sale as follows: first, to the expense of advertising, selling and conveying the Real Estate and foreclosing this mortgage, including a reasonable attorney's fee; second, to the payment of any amounts that have been spent, or that it may then be necessary to spend, in paying insurance premiums, reasonable attorney's tee; second, to the payment or any antituding their bearings of the debt and interest thereon, whether the same shall or shall be not have fully matured at the date of said sale, but no interest shall be collected beyond the day of sale and any uncorned interest shall be credited to the Mortgagor; not have fully matured at the date of said sale, but no interest shall be collected beyond the day of sale and any uncorned interest shall be credited to the Mortgagor; and fourth, the balance, if any, to be paid to party or parties appearing of record to the owner of the Real Estate at the time of sale, after deducting the cost of ascertaining who is such owner. The Motgagor agrees that the Mortgagee may bid at any sale had under the terms of this mortgage and may purchase the Real Eslate if the highest bidder therefor. At the foreclosure sale the Real Estate may be offered for sale and sold as a whole without first offering it in any other menner or may be offered for sale and sold in any other menner the Mortgages may slect. The Mortgagor agrees to pay all costs, including reasonable aborney's fees, incurred by the Mortgagee in collecting or securing or attempting to collect or secure the debt, or any part thereof, or in defending or attempting to defend the priority of this mortgage against any lien or encumbrance on the Real Estate, unless this mortgage is herein expressly made subject to any such lien or encumbrance; and/or all costs incurred in the foreclosure of this mortgage, either under the power of sale contained herein, or by virtue of the decree of any court of competent jurisdiction. The full amount of such costs incurred by the Mortgages shall be a part of the debt and shall be secured by this mortgage. The purchaser at any such sale shall be under no obligation to see to the proper application of the purchase money. In the event of a sale hereunder, the Mortgages, or owner of the debt and mortgage, or auctioneer, shall execute to the purchaser for and in the name of the Mortgagor a deed to the Real Estate."

Plural or singular words used herein to designate the undersigned shall be construed to refer to the maker or makers of this mortgage, whether one or more natural persons. All convenants and agreements herein made by the undersigned shall bind the heirs, personal representatives, successors and easigns of the undersigned, and every option, right and privilege herein reserved or secured to the Mortgages, shall inure to the benefit of the Mortgages's successors and sesigns.
