they requested the Mortgagee to grant an extension of time of payment of said mortgage indebtedness so as to make the same payable as hereinafter set forth, and the Mortgagee has agreed to grant such extension upon the terms and conditions hereinafter stated:

Existing Mortgage will secure two(2) separate notes listed as follows:
One Note payable in 16 installments of \$1,478.65 beginning on April 18, 1989 and continuing monthly until paid in full.
ALSO, one note dated 3-27-89 in the principal amount of \$25,000.00 payable in 11 installm of \$300.00 beginning on April 26 and continuing monthly until a final Payment of \$24,928. will be due on March 26, 1990.
