ORDINANCE NO. 89-46

AN ORDINANCE TO DIVIDE THE CITY OF BIRMINGHAM INTO NINE SINGLE-MEMBER COUNCIL DISTRICTS, AND TO PROVIDE FOR THE MANNER OF ELECTION, TERM OF OFFICE AND THE ELIGIBILITY OF CANDIDATES ELECTED TO THE COUNCIL FROM DISTRICTS.


BE IT ORDAINED by the Council of the City of Birmingham as follows:

Section 1. It is hereby established and declared that the City shall change the manner in which its nine (9) Council members are elected from the City at large election system provided for in Act No. 452 (1955), as amended (hereinafter referred to as the "Mayor-Council Act"), to the election of its Council members from nine single-member districts, as authorized by Ala. Code Section 11-43-63 (1988 Supp.) (hereinafter referred to as "Section 11-43-63").

Section 2. The City shall elect all nine Council members at its regular general municipal election, commencing on the second Tuesday in October of the year 1989. Each candidate for district Council member who receives a majority of the total votes cast in his or her Council district in the general election shall be elected for that district. In the event that any one candidate

should fail to receive such a majority of the total votes from his or her district in the first election, then for such district(s) a second (or run-off) election shall be held on the third Tuesday thereafter in the same mode and manner and under the same rules and regulations as the first election. In the second election, there shall be two (2) candidates for each Council district seat to be filled in such election; and these candidates shall be the ones who received the highest number of votes in said Council district, but who were not elected in the first election. receiving the higher number of votes cast in each district for which a second election is held shall be elected, so that in the first and second elections all nine Council members shall be No voter shall vote in either election provided for in this section more than one time; nor shall any voter cast a vote in either election for more than one candidate for Council. Only voters residing within a Council district shall be entitled to vote for candidates seeking election as their district Council member.

Section 3. The Council shall consist of nine members who shall be known as district Council members. The term of office for the nine district Council members elected from the single-member districts shall commence on the fourth Tuesday in November following their election. District Council members elected under the provisions of this Ordinance shall hold office for a term of four (4) years and until their successors are elected and qualified. Subsequent


elections of Council members shall be held at the same time and in the same manner as provided for in Section 2 of this Ordinance.

Section 4. No provision of this Ordinance shall have the purpose or effect of increasing or decreasing the number of Council members established by the Mayor-Council Act. Section 11-43-63 specifically authorizes the City to divide itself into singlemember districts, not to exceed nine in number.

Section 5. No provision of this Ordinance shall have the purpose or effect of changing the time or manner for election to the Office of Mayor of the City of Birmingham, as specified in the Mayor-Council Act.


Section 6. Elections shall, except as otherwise provided herein, be governed by the general provisions of Alabama law relating to municipal elections for Class 1 cities.

Section 7. Any person seeking to become a candidate in any election for the office of district Council member may become such candidate by filing in the office of the Judge of Probate of Jefferson County, Birmingham Division, a statement in writing of such candidacy and an affidavit taken and certified by such Judge of Probate or by a notary public that such person is duly qualified to hold the office for which he or she desires to be a candidate. Such statement shall be filed at least 21 days before the first day



set for the general election and shall be in substantially the following form: "State of Alabama, _____ County. I, the undersigned, being first duly sworn, depose and say that I am a citizen of the City of Birmingham, in said State and County, and reside at _____, in said City of Birmingham, that I desire to become a candidate for the office of district Council member for District Number ____, in said City at the election for said office to be held on the ____ day of October next and that I am duly qualified to hold said office if elected thereto and I hereby request that my name be printed upon the official ballot at said election. Signed _____; on this ____ day of _____, 19___, and filed in this office for record on said _____, Judge of Probate." Said statement day. shall be accompanied by a qualifying fee in the amount of \$50.00, which fee shall be paid over by the Judge of Probate to the general 발 fund of the City of Birmingham. At every such election all ballots to be used by voters shall be printed and prepared by the election commission or body or official charged by law with the duty of S conducting elections, and at the expense of the City of Birmingham, and shall contain the names of all candidates, grouped by district, directly underneath the words "For Members of the Council." No name shall appear upon said ballot as a candidate for election except the names of such persons who have become candidates according to provisions as above set forth; no ballot shall be used at any such election except the official ballot prepared by the election commission or other body or official charged by law with



the duty of conducting elections, except that the names of candidates may be suitably placed on voting machines if such machines are used to conduct such election. No primary election shall be held for the nomination of candidates for the office of council member, and candidates shall be nominated and elected only as hereinabove provided.

each district Council member shall reside within the boundaries of the Council district for which he or she seeks election, and shall reside within the district during his or her term of office on the council. Further, each candidate for election to a place on the council shall have resided within the district from which he or she seeks election for a period 90 days immediately preceding the date of the first election of the general municipal election. In addition, Council members shall meet the eligibility requirements set forth in Section 3.04 of the Mayor-Council Act, which said requirements are incorporated herein as a part of this Ordinance. If a Council member shall cease to possess any of the eligibility requirements enumerated in this section or Section 3.04 of the Mayor-Council Act, his or her office shall immediately become vacant.

Section 9. The Council shall elect an officer of the City who shall have the title of President of the Council and shall preside at meetings of the Council. The Council shall also elect a



President Pro Tem, who shall act as President of the Council during the absence or disability of the President. The term of office of the President and the President Pro Tem shall be until the Council members shall qualify following the next succeeding quadrennial election. If a vacancy shall occur in the office of President of the Council, the Council shall elect a successor in said office for the completion of the unexpired term. Both the President of the Council and the President Pro Tem shall be elected from among the Council members.

member who was elected to the Council during the October, 1987 general municipal election and who was elected to serve a four (4) year term of office shall have his or her four year term of office reduced to a two (2) year term of office. It is the intent and purpose of this section to enable and facilitate the election of all the initial district Council members during the same general municipal election, commencing on the second Tuesday in October of 1989 and with subsequent general municipal elections every four years thereafter.

Section 11. (A) There shall be established nine (9) Council districts to be designated respectively as District Number 1, District Number 2, District Number 3, District Number 4, District Number 5, District Number 6, District Number 7, District Number 8, and District Number 9, which districts shall have as nearly as is

reasonable, the same population. The designation and boundaries of the initial Council districts are specifically described and set forth in Appendix One hereof. Further, Appendix One designates district subsections and voting places for voter convenience. Appendix One is incorporated herein as a part of this Ordinance.

member Council district boundaries for each said district shall be maintained in the office of the City Clerk of Birmingham and shall be available for inspection by the public at all reasonable times.

Further, the Council, pursuant to Section 3.17 of the Mayor-Council Act, hereby declares and establishes that the districting map be made a part of this Ordinance by reference thereto as Appendix Two and without the publication of such map in any newspaper. In the event there is a conflict in the Council district boundary lines set forth in Appendix One and Appendix Two, the boundary lines depicted on the map shall govern.

Section 12. Whenever there shall be a change in population in any of the nine districts heretofore established, as evidenced by a federal census of population published following the last federal census of population preceding the adoption of this Ordinance, there shall be a reapportionment of the Council districts in the manner hereinafter provided:

(a) The Mayor shall, within six months after the publication of each federal census of population for the City, file with the Council a report containing a recommended plan for reapportionment


of the Council district boundaries to comply with the following specifications:

- (i) Each district shall be formed of contiguous and, to the extent reasonably possible, compact territory, and its boundary lines shall be the center lines of streets or other well-defined, boundaries.
- (ii) Each district shall contain as nearly as is reasonable the same population.
- (b) The report shall include a map and description of the districts recommended and shall be drafted as a proposed ordinance and considered by the Council as other ordinances are considered.

 Once filed with the clerk, the report shall be treated as an ordinance introduced by a Council member.
 - (c) The Council shall enact a redistricting ordinance within six months after receiving such report. If the Council fails to enact the redistricting ordinance within the said six months, the redistricting plan submitted by the Mayor shall be deemed effective without further action by the Council, as if it were a duly enacted ordinance.
 - (d) Such redistricting ordinance shall not apply to any regular or special municipal election held within six months after its becoming effective. No incumbent Council member shall be deprived of his or her unexpired term of office because of such redistricting.

Section 13. All ordinances, laws, and resolutions, or parts

thereof, relating to or affecting the manner in which the City elects its Council members, their terms in office and their qualifications shall be superceded to the extent that the same are inconsistent with the provisions of this Ordinance and Section 11-43-63. This Ordinance shall change the manner in which Council members are elected, their terms in office and their qualifications, only to the extent expressly and impliedly authorized in Section 11-43-63.

shall be held invalid by a court of competent jurisdiction, such holding shall not affect the remainder of this Ordinance nor the context in which such section, or part thereof, so held invalid may appear, except to the extent that an entire section, or part thereof, may be inseparably connected in meaning and effect with the section, or part thereof, to which such holding shall directly apply.

Section 15. This Ordinance shall become effective immediately upon its adoption by the Council, or upon its otherwise becoming a law. Within five (5) days after the adoption of this Ordinance by the Council, the Clerk of the City of Birmingham shall file with the Judge of Probate of Jefferson County, Birmingham Division; a certified copy of this Ordinance accompanied by the map contained in Appendix Two which shows the boundaries of all such Council districts.
