

WARRANTY DEED

Lot 12, Block 4, according to a Resurvey of Block 4 of a Resurvey of Breckenridge Park, as recorded in Map Book 9, page 150, in the Probate Office of Shelby County, Alabama. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any, of record.

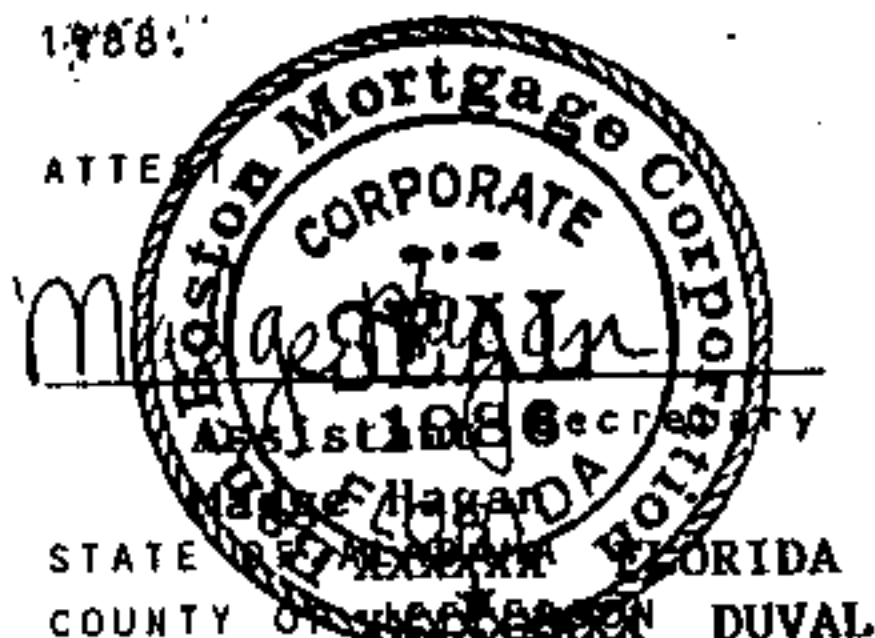
