DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Ten Dollars (\$10.00) and other good and valuable consideration to the undersigned Grantor, in hand paid by the Grantee herein, the receipt and sufficiency whereof is hereby acknowledged, 2154 TRADING CORPORATION, a New York corporation (herein referred to as "Grantor"), does hereby grant, bargain, sell and convey unto SOUTHERN COMPANY SERVICES, INC., an Alabama corporation, (herein referred to as "Grantee"), all that certain real estate situated in Shelby County, Alabama, set forth and fully described in Exhibit "A" which is attached hereto and made part hereof (all of the above-described property being referred to herein as the "Property").

The Property conveyed hereby is subject to:

1. Taxes for the current year which are a lien but not yet due and payable.
2. Mineral and mining rights not owned by Grantor.
3. Easements, rights-of-way, and restrictions of record.
4. The Property shall be used for a helicopter pad only, with related paving and curbs, and for no other use whatsoever without the prior written consent of Grantor, which consent may be withheld for any reason or for no reason whatsoever. Grantee shall use the Property strictly in compliance with all laws, statutes, ordinances, rules or regulations of Shelby County, Alabama, or any other governmental authority having jurisdiction over the use of the Property. Grantor, its successors and assigns shall have all remedies at law or in equity, including, without limitation, specific performance and/or injunctive relief in the event of a violation of this provision of this Deed.

TO HAVE AND TO HOLD unto the Grantee, subject to the exceptions and covenants contained above, until the earliest to occur of (i) October 1, 1997; (ii) such time as Grantee is no longer a tenant under leases with Grantor, occupying any portion of that certain property known as Buildings 40, 42 and 44 at Inverness Center; or (iii) the sale, transfer, conveyance or other disposition of the Property by Grantee, at which time title to the Property shall automatically revert and pass to the Grantor, its successors

and assigns, subject only to exceptions numbered 1, 2 and 3 hereinabove set forth in this instrument, without any further conveyance or action on the part of the Grantee.
