

All installation, maintenance and repairs (except emergency repairs) to be performed on days when the golf course is closed.

The Grantor shall not be liable for any damage to the facilities placed in this easement regardless of the cause or conditions resulting in the damage.

Upon abandonment by the Grantee, all rights granted herein shall revert to the Grantor without notice to or from either party hereto.
