Consent to Sole Director

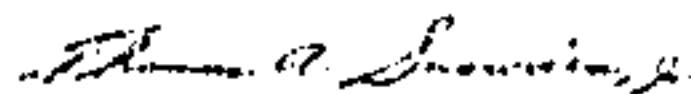

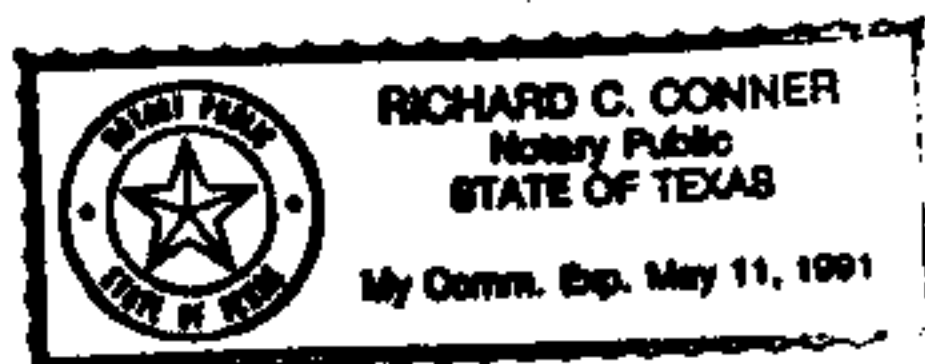
