SPECIAL DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, Mary Ann Smith, of the County of Shelby, State of Alabama, do hereby nominate, constitute, and appoint Billy S. Smith my true and lawful attorney-in-fact, for me and in my name, place and stead, and for my use and benefit:

To ask, demand, sue for, recover, collect, deposit and receive all sums of money, debts, dues, accounts, legacies, bequests, interest, dividends, annuities, and demands whatsoever as are now or shall hereafter become due, owing, payable, or belonging to me, and have, use, and take all lawful ways and means in my name or otherwise, and to compromise and agree to the same and give acquittances or other sufficient discharges for the same; to pay my bills, debts, and living expenses from my personal funds and accounts.

AND also for me and in my name, and as my act and deed, to sign, execute, deliver and acknowledge such instruments in writing of whatsoever kind and nature as may be necessary or proper in the premises;

GIVING AND GRANTING unto my said Attorney-in-Fact full power and authority to do and perform every act necessary, requisite, or proper to be done in and about the premises as fully as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney shall lawfully do or cause to be done by virtue hereof.

This power of attorney shall become effective upon my disability, incompetency, or incapacity, and shall not be affected by my disability, incompetency, or incapacity. If, following execution of this power of attorney, a court of my domicile appoint a guardian, curator, or other fiduciary charged with the management of all of my property, or all such property except specified exclusions, the court shall appoint BILLY S. SMITH except for good cause or disqualification.
