corporation by Articles of Merger filed with the Alabama Secretary of State on September 30, 1985, and a certified copy thereof was filed with the
Judge of Probate of Montgomery County, Alabama, on October 2, 1985 in Corp. 0141, Page 0428. Finance One of Alabama, Inc., was thereafter merged
into Manufacturers Hanover FS Corporation, a Delaware corporation, by Certificate of Merger filed with the Secretary of State of the State of Delaware
effective December 31, 1986, in which the survivor changed its name to Manufacturers Hanover CS Corporation. A certified copy of the said Certificate
of Merger was recorded with the Probate Judge in Jefferson County, Alabama on December 31, 1986 at Volume 3080, page 099. Additionally, Articles
