ARTICLES OF INCORPORATION
OF

WE, the undersigned, being over the age of 21 years, and acting as incorporators of American Marking, Inc., a corporation duly formed under the laws of ALABAMA, adopt the following Articles of Incorporation for such corporation:

- I. The name of the corporation is American Marking, Inc.
- II. The period of duration for the corporation is perpetual.
- III. The purpose or purposes for which the corporation is organized are:
 - A. The buying and selling of business and marking equipment and related articles.
- IV. The aggregate number of shares which the corporation shall have authority to issue is one thousand (1000) common shares with a par value of one hundred dollars (\$100.00).
- V. The regulation of the corporation shall lie with the Board of Directors who shall direct all internal affairs of the corporation.

In no event shall the number of shareholders exceed thirty (30).
