

## ASSIGNMENT OF JUDGMENT

Stephens, for a valuable consideration paid to Assignor, the receipt of which is hereby acknowledged, does hereby sell, assign, transfer, and convey to First American Title Insurance Company ("Assignee"), all Assignor's right, title and interest in and to a certain judgment recovered by Assignor in the Circuit Court for Shelby County, Alabama, CV 88-007, against Franklin Dean Smith d/b/a Franklin Properties, Inc., on the 8th day of November, 1988, for Twenty Thousand One Hundred Seventy Dollars and 33/100 (\$20,170.33) and costs.
