ORDINANCE NO. 89- 153

AN ORDINANCE AMENDING ORDINANCE NO. 89-46, ADOPTED BY THE CITY COUNCIL ON MARCH 28, 1989, TO CHANGE THE LOCATION OF CERTAIN VOTING PLACES, AS DESIGNATED IN SECTION 11(A) AND APPENDIX ONE.

BE IT ORDAINED by the Council of the City of Birmingham, Alabama, that Ordinance No. 89-46, adopted by the City Council on March 28, 1989, is hereby amended as follows:

1. Ordinance No. 89-46, Section 11(A) designates district subsections and voting places, as listed in Appendix One thereto and incorporated therein by reference.

2. 3. All previous ordinances designating voting places for the municipal election to be held on October 10, 1989, and any run-off election which may be necessary, and any subsequent municipal election are hereby superceded to the extent that the same are inconsistent with this Ordinance.

4. No provision of this Ordinance shall have the purpose or effect of changing any of the designations and boundaries of the Council districts and district subsections specifically described and set forth in Appendix One of Ordinance No. 89-46.

5. If any section, or part thereof, of this Ordinance shall be held invalid by a court of competent jurisdiction, such holding shall not affect the remainder of this Ordinance nor the context in which such section, or part thereof, so held invalid may appear, except to the extent that an entire section, or part thereof, may be inseparably connected in meaning and effect with the section, or part thereof, to which such holding shall directly apply.

6. This Ordinance shall become effective immediately upon its adoption by the Council, or upon its otherwise becoming a law.
