SPECIAL DURABLE POWER OF ATTORNEY

To ask, demand, sue for, recover, collect, deposit and receive all sums of money, debts, dues, accounts, legacies, bequests, interest, dividends, annuities, and demands whatsoever as are now or shall hereafter become due, owing, payable, or belonging to me, and have, use and take all lawful ways and means in my name or otherwise, and to compromise and agree to the same and give acquittances, or other sufficient discharges for the same; to pay my bills, debts, and living expenses from my personal funds, and accounts.

AND also for me and in my name, and my act and deed, to sign, execute, deliver and acknowledge such instruments in writing of whatsoever kind and nature as may be necessary or proper in the premises;

This power of attorney shall become effective upon my disability, incompetency, or incapacity, and shall not be affected by my disability, incompetency, or incapacity. If, following execution of this power of attorney, a court of my domicile appoint a guardian, curator, or other fiduciary charges with the management of all of my property, or all such property except specified exclusions, the court shall appoint HANNELORE GERHARD, except for good cause or disqualification.
