AFFIDAVIT OF VIRGINIA MAE NORRIS AND

Before me, the undersigned Notary Public, personally appeared Virginia Mae Norris and Marie Ransom, who, being known to me and both of whom being first duly sworn, did depose and say as follows:

1. That Virginia Mae Norris and Marie Ransom are sisters, the only naturally born children of Ed Daniels and wife, Ardella Daniels.

2. That the said Virginia Mae Norris and Marie Ransom are the only surviving heirs of Ed Daniels (whose date of death is March 8, 1956) and Ardella Daniels (whose date of death is May 25, 1988).

3. That the said Ed Daniels and wife, Ardella Daniels are the same parties as were conveyed the following parcels of land, both parcels being located in Shelby County, Alabama:

a) Lot No. (2) in block B in Nickerson addition to Alabaster, Alabama. Situated in Section One, Township 21, Range 3 West. As recorded in Vol. 132, Record of Deeds, page 550 on the 19th day of November, 1948. (Deed executed by T.H. Hosey and wife, Lottie Hosey on the 24th day of December, 1947).

b) Lot No. 5 in Block B in Nickerson Addition to Alabaster. Lying and being in Section One, Township 21, Range 3 West. As recorded in Vol. 122 Record of Deeds, page 237, on the 13th day of December, 1945. (Deed executed by Will Wright and wife, Dora Wright on the 28th day of September, 1945).

4. That the said Ed Daniels is one and the same person as the said Ed Danners, and that the said Ed Daniels/Danners was the natural father of Virginia Mae Norris and Marie Ransom, having been born on the 8th day of May 1907, in Dallas County, Alabama.

5. That the said Ardella Daniels is one and the same person as the said Mary Della Robinson Daniels/Danners, and that the said Mary Della Robinson "Ardella" Daniels/Danners, was the natural mother of Virginia Mae Norris and Marie Ransom, having been born on the 4th day of October, 1921 in Shelby County, Alabama.

6. That the said Ed Daniels/Danners and the said Mary Della "Ardella" Robinson Daniels/Danners were married on the 6th day of December, 1936 in Shelby County, Alabama as recorded in Marriage Book 8, page 130 as located in the Office of the Probate Judge of Shelby County, Alabama.

7. That upon the death of Mary Della "Ardella" Daniels on the 25th day of May, 1988, Virginia Mae Norris and Marie Ransom are the sole heirs of said real estate.

8. That neither Ed Daniels/Danners nor Mary Della "Ardella" Robinson Daniels/Danners died leaving a Last Will and Testament and neither died leaving an estate needing to be administered pursuant to the Laws of The State of Alabama in regards to Administration of Estates.
