ARTICLES OF INCORPORATION
OF
ALABAMA TRAFFIC SAFETY COALITION
(A Non-Profit Corporation)

ARTICLE I

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation shall be the Alabama Traffic Safety Coalition, Inc.

SECOND: The period of duration shall be perpetual.

THIRD: The purposes for organizing the Alabama Traffic Safety Coalition, Inc. are:

a. To foster constructive and progressive legislation relating to safety of passengers in motor vehicles through the use of seat belt restraint mechanisms.

b. To acquire, preserve, and disseminate information pertinent to the use of safety belts.

c. To work with individuals, organizations and governmental agencies toward the achievement of responsible safety legislation.

d. To develop a statewide public information program and community support base.

e. To the extent its facilities, resources, and manpower will permit, its services will be extended to coordinate with other agencies and educational organizations of the community to accomplish the goals set forth herein.

FOURTH: The corporation shall have members and the specific information with respect to members shall be included in the corporate by-laws.
