Commence at the NW Corner of the NW 1/4 of the NE 1/4 of Section 34, Township 19 South, Range 1 West, thence run East along the North line of said 1/4 - 1/4 for 91.65 feet; thence turn an angle to the right of 90 degrees and run 191.28 feet to the Point of Beginning; thence turn an angle to the left of 41 degrees 57 minutes and run 65.93 feet; thence turn an angle to the left of 90 degrees and run 9.30 feet; thence turn an angle to the right of 90 degrees and run 68.90 feet; thence turn an angle to the right of 90 degrees and run 54.88 feet; thence turn an angle to the left of 33 degrees 16 minutes and run 66.09 feet; thence turn an angle to the right of 126 degrees 12 minutes and run 173.28 feet; thence turn an angle to the right of 88 degrees 14 minutes and run 91.94 feet to the Point of Beginning.
