I, the undersigned, hereby certify that Alabama Power Company does not claim the right to construct additional lines for the transmission of electricity over or across the lands described herein below, under the authority granted in the following right of way permit:

That certain instrument from A. C. Gilbert and wife, Elizabeth Gilbert dated May 19, 1947 and recorded in Deed Book 129, at page 567 of the Probate Court records in and for Shelby County, Alabama.

The purpose for which such right of way permit was acquired was for a distribution line that was constructed, but subsequently removed from the property described below:

Commence at the northwest corner of the southwest quarter of the northwest quarter of SEction 21, Township 19 South, Range 2 West; thence run in a southerly direction along the west line of said quarter-quarter a distance of 118.61 feet to a set 1/1" rebar on the north right of way line of Shelby County Road No. 17; thence turn left an angle of 139 degrees 11' 39" and run in a northeasterly direction along said right of way a distance of 93.45 feet to the point of a curve to the left having a central angle of 14 degrees 22' 50" and a radius of 2075.22 ft.; thence run along the arc of said curve in a northeasterly direction a distance of 520.86 ft. to the end of said curve; thence from the tangent of last described curve turn left an angle of 114 degrees 58' 21" and run in a westerly direction for a distance of 218.02 ft; thence turn right an angle of 90 degrees 00' 24" and run in a northerly direction a distance of 91.20 ft; thence turn left an angle of 90 degrees 00' 37" and run in a westerly direction a distance of 133.08 ft. to the point of beginning.
