This action came on for trial on March 6, 1985, before the Court and a jury, Honorable U.W. Clemon, United States District Judge, presiding, and the issues having been duly tried and the jury having duly rendered its verdict,

It is ORDERED and ADJUDGED that the plaintiff Joel Rice have and recover of the defendant J.D. "Joe" Vizzina, d/b/a Associated Wholesalers of Alabama, Inc., the sum of \$6,840.00 in compensatory damages and the sum of \$10,000.00 in punitive damages, in accordance with verdict of the jury this day filed as follows:

"We, the jury, find in favor of the plaintiff, Joel Rice and against defendant J.D. "Joe" Vizzina, d/b/a Associated Wholesalers of Alabama, Inc., and fix compensatory damages in the amount of \$6,840.00 based on our finding(s) that the defendant has X violated the Motor Vehicle Information and Costs Savings Act; X perpetrated legal fraud breached his contract with plaintiff and taxing costs against the defendant. Punitive damages X are, are not, Awarded in the amount of \$10,000.00";

It is further ORDERED that the defendant pay direct to the attorneys of record for the plaintiff the proceeds of the judgment and costs recovered herein by the plaintiff, and that upon receipt thereof, the attorneys of record for the plaintiff will satisfy said judgment on the records of this court.
